Payment Plans

We understand that the school depends on faithful payment of tuition and fees and has several different payment plans available.

Our family prefers to make tuition payments:

We understand that ALL payments are due on or before the Fifteenth of the month – A charge is levied for each month Or fraction thereof in which a payment is late.

Some years a discount is available for these payment plans – the school office can advise you as to the availability and amount of this discount.

Students enrolling after the beginning of the school year, or leaving before the end of the school will have their tuition adjusted pro-rata plus a materials fee.
